- 1. The concerned candidate will remain on probation for a period of two years.
- 2. The concerned candidate will have to produce the medical certificate from the Chief Medical Officer, Shimla-171001.
- 3. The conditions of his service will be regulated by prevalent Rules and orders/ instructions issued by the Government from time to time.
- 4. The candidate will be entitled to benefits as per the contributory Pension Scheme introduced vide Finance (Pension) Department Notification No. Fin (Pen)A(3)-1/96 dated 17-08-2006 like other employees of the State Government who have been appointed to service after 15-05-2003.
