- 1. The concerned candidate will remain on probation for a period of two years.
- 2. The concerned candidate will have to produce the medical certificate from the Chief Medical Officer /Medical Officer of the district/area.
- 3. The conditions of their service will be regulated by prevalent Rules and orders/ instructions issued by the Government from time to time.
- 4. The candidate will be entitled to benefits as per the contributory Pension Scheme introduced vide Finance (Pension) Department Notification No. Fin (Pen)A(3)-1/96 dated 17-08-2006 like other employees of the State Government who have been appointed to service after 15-05-2003.
- 5. The regularization is subject to the verification of their character and antecedents. In case this is not found satisfactory, the service shall be liable to be terminated forthwith.
- 6. The concerned candidate will have to take an oath of allegiance and faithfulness to the constitution of India.
- 7. The concerned candidate will furnish a declaration to the effect that he/she is not a dismissed employee of any Govt./Semi Govt. Department/Organization.
- 8. The concerned candidate will furnish a declaration to the effect that he/she has only one living spouse.
- 9. The candidate will have to give in writing, whether he/she was ever convicted by any criminal court or any departmental proceeding/ vigilance case is not pending against him /her.
- 10. The candidate will have to submit category certificate to which he/she belongs issued by the competent authority.
- 11. The candidate will have to submit a return of assets and liabilities as required under rule 18(1) of the CCS (Conduct) Rules 1964.
- 12. Regularization of services can be terminated at any time by giving one month notice or by paying a sum equivalent to salary of a month or a sum equivalent, for a period by which the period of notice fall short or one month

without assigning any reason or if any discrepancy comes to the notice at a later stage.
