OFFICE ORDER

In pursuance to the instructions issued by the Department of Personnel (AP-III) vide letter No. PER(AP)-C-B(2)-2/2015, Dated 22-04-2016 and on the recommendation of the Screening Committee, the services of Sh. Sanjay Sheel (General), Sh. Om Kumar (General BPL) and Sh. Maharaj Singh (ST) Junior Auditor on contractual basis of this department, who has completed five years service as on 31-03-2016, are hereby regularized against the vacant post of Junior Auditor, on the order of above merit in the pay scale of Rs. 10300-34800+3800 (With initial start of Rs. 14590/-PM) plus allowances, with immediate effect, subject to the terms and conditions given below:-

1. The concerned candidate will remain on probation for a period of two years.
2. The concerned candidate will have to produce the medical certificate from the Chief Medical Officer /Medical Officer of the district/area, before joining the post.
3. The conditions of their service will be regulated by prevalent Rules and orders/instructions issued by the Government from time to time.
4. The candidate will be entitled to benefits as per the contributory Pension Scheme introduced vide Finance (Pension) Department Notification No. Fin (Pen)A(3)-1/96 dated 17-08-2006 like other employees of the State Government who have been appointed to service after 15-05-2003.
5. The regularization is subject to the verification of their character and antecedents. In case this is not found satisfactory, the service shall be liable to be terminated forthwith.
6. The concerned candidate will have to take an oath of allegiance and faithfulness to the constitution of India.
7. The concerned candidate will furnish a declaration to the effect that he/she is not a dismissed employee of any Govt./Semi Govt. Department/Organisation.
8. The concerned candidate will furnish a declaration to the effect that he/she has only one living spouse.
9. The candidate will have to give in writing, whether he/she was ever convicted by any criminal court or any departmental proceeding/ vigilance case is not pending against him /her.
10. The candidate will have to submit category certificate to which he/she belongs issued by the competent authority.
11. The candidate will have to submit a return of assets and liabilities as required under rule 18(1) of the CCS(Conduct) Rules 1964.
12. Regularization of services can be terminated at any time by giving one month notice or by paying a sum equivalent to salary of a month or a sum equivalent, for a period by which the period of notice fall short or one month without assigning any reason or if any discrepancy comes to the notice at a later stage.



In case the above terms and conditions are acceptable to them, they should report for duty at the Headquarters Office of Local Audit Department, H.P. Shimla-171009, within 15 days from the date of issue of these orders, failing which the offer will stand cancelled.
