- 1. The candidates shall be engaged as Trainee Junior Auditor.
- 2. The candidate engaged as Trainee shall sign an agreement as per Annexure-A appended to these orders.
- 3. The regularisation of the incumbents engaged as Trainees will be governed by the instructions issued in this regard by the Government, after completion of training.
- The Trainee Junior Auditor will be paid consolidated fixed amount @ ₹23100/- P.M. (which shall be 60% of the first cell of the applicable level of pay matrix of the corresponding cadre)
